Consider, discuss and vote on the issuance of Housing Finance Authority of Lee County Florida, as Issuer of its Multi-Family Mortgage Revenue Bonds, Series 2017, in an aggregate of principal amount of not to exceed of \$14,000,000.00 in connection with the application described below and to enter into an Inducement Resolution with such entity.
