("University Club"), for the Authority to subordinate the Land Use Restriction Agreement that it entered into in connection with the Authority's issuance of its Multifamily Housing Revenue Bonds (University Club Apartments) Series 2002A and Taxable Multifamily Housing Revenue Bonds, Series 2002B (University Club Apartments) collectively the "Bonds"), including, but not limited to the Authority's entering into that certain agreement known as the "Amendment to Land Use Restriction Agreement (University Club Apartments Project)" or possible termination of the Land Use Restriction Agreement and such other and further documents as are necessary to allow University Club to redeem, pay off, defease and discharge the aforementioned Bonds.
