

**NOTICE OF REGULAR MEETING OF

PUBLIC NOTICE is hereby given that the Housing Finance Authority of Lee County, Florida (the "Authority") will conduct a regular meeting on Thursday, October 24, 2019, at 4:00 p.m. at the offices of PHILIP L. Consider, discuss and vote on the issuance of Housing Finance Authority of Lee County, Florida, as Issuer of its Multi-Family Mortgage Revenue Bonds, Series 2020, in the aggregate principal amount of not to exceed \$12,500,000.00 in connection with the application described below and to enter into an Inducement Resolution with such entity. The proceeds of such bonds may be used to finance the acquisition, construction, rehabilitation, and equipping of the following residential rental Project:

5. Consider and discuss bills and invoices submitted to the Authority for approval and payment and update signatory members on Authority's checking and savings accounts, CDs, etc.
6. Such other matters as may come before the meeting.
